1. T-08.4.ST (Wayne)

On January 4, 2008 Harold F. Stacey dba Stacey Transfer & Storage, Great Falls, Montana filed an application to transfer PSC No. 346 to Stacey Transfer and Storage LLC, Great Falls, Montana. The transfer was noticed to the public on February 11, 2008 and no protests were received.

SUB A Class C - Property, in the City of Butte, Montana, and to or from points immediately tributary thereto. Limitations: The transportation of property between points served by rail carriers, or between points served by a motor carrier operating between fixed termini or over a regular route, is prohibited.

SUB B Class C - Property, in the City of Great Falls, Montana, and to or from points immediately tributary thereto, but not exceeding a distance of ten (10) miles in any direction from said city. Limitations: The transportation of property between points served by rail carriers, or between points served by a motor carrier operating between fixed termini or over a regular route, is prohibited.
