**Action Items** All items identified below are for action at the Commission business meeting.

1. T-08.25.OTSC (Wayne)

On May 20, 2008 an Order to Show Cause was issued to Cary M. Sarles dba Park County Transportation, Livingston, Montana, PSC No. 9456 for failure to file a 2007 Annual Report. The Order to Show Cause was sent by certified mail. It was returned to this office as unclaimed. The motor carrier was contacted by telephone twice and no report has been filed.

Class B – Passengers between all points and places within a one hundred twenty-five (125) mile radius of Livingston, Montana. . LIMITATIONS: 1) Service in the city limits of Livingston is prohibited. 2) Movements to or from Gallatin Field must originate or terminate in Park County, Montana. 3) Movements in Big Sky, Montana and a twenty-five (25) mile radius are prohibited. 4) Seating capacity will be no more than six (6) passengers per vehicle. 5) Services as a limousine are prohibited. 6) Movements to or from Bozeman, Montana must originate or terminate in Park County and require a one (1) week advance reservation. 7) Transportation to or from Billings, Montana must originate or terminate at Logan International Airport and a three (3) mile radius thereof.

**STAFF RECOMMENDATION:** Cancel PSC No. 9456 for failure to file a 2007 Annual Report.

2. TN2396 (Wayne)

UG, Inc. dba Capitol Taxi, Helena, Montana, PSC No. 2111, requests a fuel surcharge of between \$.25 and \$1.50 per fare on their passenger operations. The amount of the fuel surcharge is based on the distance traveled. Based on past ridership, the \$.25 surcharge will cover 60% of the rides provided. The fuel surcharge would be in effect for the period July 1, 2008 to September 29, 2008.

SUB C Class B - Persons, baggage and express within the city limits of Helena, Montana and a fifty (50) mile radius thereof.  
LIMITATION: Transportation of passengers requiring wheelchair van service is prohibited.
