Action Items All items identified below are for action at the Commission business meeting.

1. TN2410 (Wayne)

Mining City Taxi LLC, Butte, Montana requests a continuation of a fuel surcharge of \$.50 per fare on their passenger operations under PSC No. 321. The fuel surcharge was originally granted June 24, 2008. This fuel surcharge would be in effect for the period October 1, 2008 to December 30, 2008.

Class B - Persons, in the City of Butte, Montana and to or from points not exceeding fifty (50) miles of Butte, Montana.
Limitations: Regular or scheduled service as a jitney or bus is prohibited on or over any route.

STAFF RECOMMENDATION: Approve the fuel surcharge as requested.

2. TN2411 (Wayne)

UG, Inc. dba Capitol Taxi, Helena, Montana, PSC No. 2111, requests a continuation of a fuel surcharge of between \$.25 and \$1.50 per fare on their passenger operations. The amount of the fuel surcharge is based on the distance traveled. Based on past ridership, the \$.25 surcharge will cover 60% of the rides provided. The fuel surcharge was originally granted on July 1, 2008. The fuel surcharge would be in effect for the period October 1, 2008 to December 30, 2008.

SUB C Class B - Persons, baggage and express within the city limits of Helena, Montana and a fifty (50) mile radius thereof.
LIMITATION: Transportation of passengers requiring wheelchair van service is prohibited.
