Public Comments

Action Items All items identified below are for action at the Commission business meeting.

1. T-08.39.PCN (Wayne)

On September 23, 2008 Mining City Taxi LLC, Butte, Montana filed an application for a certificate of public convenience and necessity. That application was noticed to the public on October 10, 2008 and a protest

was received. The applicant added limiting language to the application and the protestant withdrew on December 15, 2008.

Class B - Passengers (1) to or from Butte-Silver Bow, Montana to Gallatin Field, at or near Belgrade, Montana; (2) to or from Butte-Silver Bow, Montana to the Helena Airport, Helena, Montana; and (3) to or from Butte-Silver Bow, Montana to all points and places in Beaverhead County, Montana. LIMITATION: Transportation of passengers by limousine or in limousine service is prohibited.

STAFF RECOMMENDATION: Approve the application as amended.
