1. T-09.5.OTSC (Wayne)

On February 23, 2009 an Order to Show Cause was issued to PSC No. 56, leased by Glacier Country Transportation Centre LLC dba Kalispell Taxi, Kalispell, Montana for failure to purchase a vehicle registration receipt for 2009 as required by 69-12-421 MCA. The Order to Show

Cause was sent certified and received by the carrier on March 12, 2009. No purchase has been made.

Class B - Persons, baggage and express within the City of Kalispell, Montana and between points and places tributary thereto, but not exceeding fifty (50) miles in any direction from said City of Kalispell.

SUB A Class B - Persons within the City of Kalispell, Montana, and to or from points tributary thereto, but within a distance not exceeding twenty-five (25) miles in any direction from said city.

SUB C Class B - Persons and hand luggage between all points and places within the town of Kalispell, Montana.

**STAFF RECOMMENDATION:** Terminate the lease for failure to comply with Commission rules and regulations and revert the authority to the owner, Flathead Area Custom Transportation, Inc. dba Kalispell Taxi and Airport Shuttle Service.

2. T-09.15.OTSC (Wayne)

On February 23, 2009 an Order to Show Cause was issued to PSC No. 9364, leased by Glacier Country Transportation Centre LLC dba Kalispell Taxi, Kalispell, Montana for failure to purchase a vehicle registration receipt for 2009 as required by 69-12-421 MCA. The Order to Show Cause was sent certified and received by the carrier on March 12, 2009. No purchase has been made.

SUB B Class B - Passengers, baggage and express between all points and places in Lincoln and Sanders Counties. Limitations: Transportation of railway crews is prohibited. Transportation by limousine is prohibited. 2) Transportation by limousine is prohibited. 3) Transportation of passengers, baggage and express between points and places in Libby, Montana and a thirty (30) mile radius thereof is prohibited. 4) Transportation of passengers, baggage and express between points and places in Eureka, Montana and a thirty (30) mile radius thereof is prohibited.

SUB C Class B - Passengers, baggage and express between all points and places in Eureka, Montana and a thirty (30) mile radius thereof. Limitations: 1) Transportation of railway crews is prohibited. 2) Transportation by limousine is prohibited.

**STAFF RECOMMENDATION:** Terminate the lease for failure to comply with Commission rules and regulations and revert the authority to the owner, Flathead Area Custom Transportation, Inc. dba Kalispell Taxi and Airport Shuttle Service.

3. T-09.21.OTSC (Wayne)

On February 23, 2009 an Order to Show Cause was issued to PSC No. 9455, Park City Limousines LC dba Yellowstone Taxicabs, West Yellowstone, Montana for failure to purchase a vehicle registration receipt for 2009 as required by 69-12-421 MCA. The Order to Show Cause was sent certified and received by the carrier on March 9, 2009. No purchase has been made.

Class B – Passengers between all points and places in West Yellowstone, Montana and a twenty-five (25) mile radius thereof. LIMITATION: Transportation is limited to service between May 7 and October 7 of each year.

**STAFF RECOMMENDATION:** Cancel the authority for failure to purchase the required vehicle registration receipt.
