1. T-09.22.ST (Wayne)

On February 11, 2009 Howard Harper, as personal representative for Mary Belle Harper dba Livingston Taxi, Livingston, Montana filed an application to transfer PSC no. 9466 to Carrie Anne Johnson dba Amazing

Taxi, Livingston, Montana. The transfer was noticed to the public on March 6, 2009 and no protests were received.

Class B – Passengers between all points and places within a 125 mile radius of Livingston, Montana. Limitations: (1) Transportation must originate or terminate in Park County, Montana. (2) Transportation to or from points east of Park County, Montana must originate or terminate in the City of Livingston, Montana.

2. T-09.12.OTSC (Wayne)

On the 17th of March, 2009 the Commission cancelled PSC No. 8924, Kindred Nursing Centers West LLC dba Parkview Acres Care & Rehabilitation Center, Dillon, Montana for failure to purchase a 2009 vehicle registration receipt. Cancellation Order 6984 was issued and received by the motor carrier on March 25, 2009. The motor carrier is requesting reconsideration of the cancellation and reinstatement of the authority. The petition for reconsideration was accompanied by a request for a vehicle registration receipt.
