TEMPORARY RATE ORDER

FINDINGS OF FACT

1. On June 13, 1977, CONSUMERS GAS COMPANY (Applicant) made application to this Commission for authority to increase rates in order to offset increased gas costs charged by Treasure State Pipe Line Company which resulted from increased gas costs charged by The Montana Power Company under Docket No. 6454.

2. Consumers Gas Company purchases one hundred per cent (100%) of its gas from Treasure State Pipe Line Company.

3. On June 9, 1977, this Commission granted Montana Power Company a temporary increase in its natural gas rates. Included in the temporary rate increase Order was authorization to increase charges to Montana Power's small utility customers.

4. On November 1, 1977, the Commission's Order No. 4350a in Docket No. 6454 granted Montana Power a second temporary natural gas rate increase.

5. Order No. 4350a will result in increased purchased gas costs to Applicant.

CONCLUSIONS OF LAW

1. Under Revised Codes of Montana 1947, Section 70-113, the Commission has authority to grant a temporary rate increase pending hearing.

2. The application of Consumers Gas Company will be noticed for hearing at a later date.

ORDER

1. Applicant, Consumers Gas Company, is authorized to increase its rates to recover increased gas costs from Treasure State Pipe Line Company as a result of Commission Order No. 4350a and to file tariffs and supporting calculations.

2. The increase granted herein is subject to rebate should the final Order in this Docket determine that a lesser increase than authorized by this Order is required.


3. In the event a rebate is directed by the final Order in this Docket, provision shall be made in that Order to cause all uncollected rebates to be escheated to the State of Montana in the manner provided by law.


4. The increased rates shall be collected upon a constant, uniform cents per mcf basis.

5. The filed tariffs shall be effective for natural gas service rendered after November 1, 1977.




