DEFAULT ORDER NO. 4831

On May 18, 1981 the Continental Pipe Line Company (Applicant) filed an application with the Montana Public Service Commission for an order to authorize an increase in its rates because of increasing expenses and declining volumes. The increase proposed would yield an approximate 9.09% rate of return.

Having considered the application and the documentation furnished by Applicant in support of its application and deeming itself fully advised in the premises, the Commission makes the following Findings of Fact and Conclusions of Law:

FINDINGS OF FACT

1. A Notice of Opportunity for Public Hearing was sent to all of the Applicant's Montana customers on June 24, 1981.
2. The Notice stated that if no requests for a public hearing were received by July 23, 1981 the Commission would consider the matter and a default order would be issued.

CONCLUSIONS OF LAW

1. The Commission has jurisdiction, granted by Section 63-13-101, MCA, over the matters in this Docket.
2. The rates approved herein are reasonable, just and

proper.






