On September 17, 1984, the Capital Answering Service Inc. (Applicant) filed a request with the Montana Public Service Commission, pursuant to jurisdiction granted by Section 69-3-103 through 69-1-107, MCA for an order authorizing Applicant to modify rates.

FINDINGS OF FACT

1. A Notice of Opportunity For Public Hearing was issued on September 28, 1984. The notice was published in the Independent Record, on Wednesday, October 4, 1984. The notice stated that if no hearing was requested by October 26, 1984, an appropriate order may be issued based upon evidence submitted with the application.
2. No request for a hearing was received and no hearing was scheduled.
3. The Commission finds the request is reasonable and hereby grants approval.

CONCLUSIONS OF LAW

1. The Montana Public Service Commission properly exercises jurisdiction over the Applicant's Montana operations pursuant to Title 69, Chapter 3, MCA.
2. The resulting rate levels are reasonable and just.

ORDER

1. IT IS HEREBY ORDERED that the rates as set forth in Appendix "A", pages 1 and 2 of 2, are approved.

2. The revised tariff is effective for services rendered on or after October 29, 1984.

DONE IN OPEN SESSION at Helena, Montana, on the 29th day of October, 1984, by a 5 - 0 vote.

Over calls .25¢ each unit over base of 70 units.

Install \$65.00 to 120.00 depending on unit and vehicle. Take out 25.00.

Rechargeable NICAD - \$7.50 each additional battery.

Discounts will be given in proportion to number of months above one month paid in advance for the base service rates.






