NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE that the Public Service Commission (PSC) will conduct a public hearing in the Matter of the Application of Utility Solutions, LLC to Implement Initial Rates and Charges for Water Service in its Elk Grove Subdivision, Gallatin County, Montana Service Area and in the Matter of the Application of Utility Solutions, LLC to Implement Initial Rates and Charges for Wastewater Service in its Elk Grove Subdivision, Gallatin County, Montana Service Area. The hearing will commence on Monday, May 3, 2010, at 7:00 p.m., in the Monforton School Gymnasium, 6001 Monforton School Road, Bozeman, Montana, and continue from day to day as necessary.

The PSC's jurisdiction over this matter is as provided by Title 69, MCA. The applicable law includes provisions of Title 69, MCA, and corresponding rules of the PSC. The hearing itself will be conducted as a contested case hearing pursuant to Title 2, Ch. 4, MCA (MAPA), and ARM Title 38, Ch. 2, PSC procedural rules. The hearing is for the purpose of receiving technical evidence (testimony and exhibits) and public comment for consideration by the PSC. The Applicant and the Montana Consumer Counsel have filed a Stipulation moved the PSC to

issue a final order approving, adopting, and implementing the Stipulation. Testimony submitted at hearing is subject to cross-examination.
