Please provide working electronic copies of all Exhibits with all supporting files and links intact.

RESPONSE:

See the attached CD for the working electronic copies of the John Smith, Bill Thomas and Glen Phelps exhibits with supporting files and links intact. The Smith and Phelps exhibits have been updated to reflect actual information for May and June 2012. Consistent with NWE's standard practice, the booked DSM lost revenues in the Smith exhibits reflect estimated lost revenues because it typically takes eight to ten weeks after the end of the tracker period to compile actual reported energy savings, and reported energy savings is a necessary input to the computation of DSM lost revenues. Accordingly, the Thomas exhibits are not updated to include actual data. NWE is in the process of gathering and finalizing actual reported energy savings for the 2011-2012 tracker period and will provide updated Thomas exhibits once that activity is complete.

NWE anticipates that any adjustment that is necessary to true-up the estimated DSM lost revenues booked for the 2011-2012 tracker period to the DSM lost revenues approved by the Commission in this docket will be made during the 2012-2013 tracker period.

Please note that information in the Thomas exhibits that would otherwise allow for the identification of individual customers has been redacted.

UPDATED RESPONSE (November 20, 2012):

See the enclosed CD for the following updated exhibits of Bill Thomas: Exhibit\_\_(WMT-1), Exhibit\_\_(WMT-2), and Exhibit\_\_(WMT-3). These three exhibits have all been updated with actual data for the full 12 months of the tracker period. The actual exhibit is the first worksheet tab in each file, and the rest of the tabs contain the supporting data and computations. Information that would otherwise allow for the identification of individual customers has been redacted.
