**NOTICE OF STAFF ACTION**

On April 30, 2015, following a scheduling conference, the Commission, through delegation of authority to staff, issued *Procedural Or. 7388c*, which set the procedural schedule in the above entitled action.

On May 21, 2015, at an off the record attorney conference at the conclusion of a hearing, the parties agreed to simultaneous post hearing briefing, with briefs due no later than **June 19, 2015**.

Additionally, the parties agreed to the following modifications to *Procedural Or. 7388c*. All dates including and subsequent to the **June 5, 2015** deadline are no longer in effect. The following dates will now apply:

- (g) June 26, 2015: Final day for intervenor testimony regarding CenturyLink's *Petition and Plan*.
- (h) July 10, 2015: Final day for data requests to intervenors.
- (i) July 22, 2015: Final day for the Commission to identify additional issues\*
- (j) July 24, 2015: Final day for intervenors to respond to data requests issued on July 10, 2015. *See Procedural Or. 7388(c) ¶ 14.*
- (k) August 14, 2015: Final day for CenturyLink to file rebuttal testimony regarding its *Petition and Plan* and for intervenors to file cross-intervenor response testimony.

(l) August 28, 2015: Final day for written discovery to CenturyLink regarding rebuttal testimony and written discovery to intervenors regarding cross-intervenor response testimony.

(m) September 11, 2015: Final day for CenturyLink's responses to written discovery regarding rebuttal testimony and intervenors' responses to written discovery regarding cross-intervenor response testimony. *See Procedural Or. 7388(c) ¶ 14.*

(n) September 25, 2015: Deadline for pre-hearing memorandum.

(o) TBA: Hearing commences and continues from day-to-day as necessary.

\*If the PSC identifies additional issues it will issue a modified procedural order and schedule, likely changing some of the deadlines k through o.
