**CITY OF MISSOULA'S SUPPLEMENTAL RESPONSE TO WESTERN WATER AND  
MOUNTAIN WATER'S MOTION FOR A PROTECTIVE ORDER  
(PSC-028(b) and PSC-029(b))**

On June 5, 2014, the PSC granted Western Water and Mountain Water's Motion for a Protective Order with respect to certain categories of information in the Project Orchard Memorandum and Management Presentation. (Order No. 7392f). The PSC ruled that complete, unredacted copies of that information must be provided to the City subject to a non-disclosure agreement.

Given the PSC's ruling and the similar nature of information at issue in Western Water and Mountain Water's Motion for a Protective Order related to PSC-028(b) and PSC-029(b), the City of Missoula withdraws its opposition to that motion as long as complete and unredacted copies of that information are provided to the City (subject to a nondisclosure agreement). The City continues to maintain that the information should be publicly disclosed, but it withdraws its opposition in the interest of judicial economy and only in light of Order No. 7392f.

The City's withdrawal of opposition applies only to PSC-028(b) and PSC-029(b) and only to the specific documents provided by Western Water and Mountain Water in their supplemental production of May 27, 2014. It does not apply to any other data requests, whether made by the PSC, Montana Consumer Counsel, or the City. Finally, the City continues to maintain that all deadlines and the hearing date should be vacated and reset as a result of Western Water, Mountain Water, and Liberty's late and incomplete responses to the data requests.
