The City identifies the following contested issue in this docket: Whether Mountain Water Company's ("Mountain Water") rates are just and reasonable in light of significant change in costs resulting from the consummation of the unauthorized transfer of ownership from the Carlyle Group to Liberty Utilities Company ("Liberty")/ Algonquin Power & Utilities Corp. ("Algonquin").
