CANCELLATION ORDER

WHEREAS, on November 2, 1999, the Montana Public Service Commission granted Montana intrastate operating authority to Victor I. Pizzola dba Valley Taxi, Hamilton, Montana by Final Order No. 6469, and subsequently Order on Reconsideration, dated January 11, 2000, Order No. 6469a, issued in Docket T-98.32.PCN, pursuant to Title 69, Chapter 12, MCA.

WHEREAS, Section 69-12-401, MCA, provides that all regulated motor carriers must comply with state law as provided in Chapter 12, and Section 69-12-402, MCA, provides that all regulated motor carriers must comply with the Commission's administrative rules promulgated to implement the statutory provisions of Chapter 12, and Title 69, Chapter 12, MCA, contains the compliance requirements for regulated motor carriers.

WHEREAS, Title 38, Chapter 3, Subchapters 1 through 12, 15, 19 through 21, 24 through 30, 33 and 34, ARM, constitute duly promulgated administrative rules providing for the requirements by which to administer and implement the provisions of Title 69, Chapter 12, MCA, and

WHEREAS, Victor I. Pizzola dba Valley Taxi, Hamilton, Montana has not completed compliance requirements after being granted a Certificate of Public Convenience and Necessity, specifically due to the failure to file evidence of a tariff covering the granted authority, with the Montana Public Service Commission.

The Montana Public Service Commission issued an Order to Show Cause pursuant to Section 69-12-327, MCA, and ARM 38.3.120, sent by certified mail and received by the carrier on March 17, 2000 requiring the carrier to show cause within ten (10) days after receipt of the Order, why the Public Service

Commission should not cancel and terminate intrastate authority granted in Docket T-98.32.PCN, Final Order No. 6469 and Order on Reconsideration 6469a.

NOW, THEREFORE, IT IS ORDERED THAT Montana intrastate operating authority granted to Victor I. Pizzola dba Valley Taxi by Final Order No. 6469 and Order on Reconsideration 6469a, issued in Docket T-98.32.PCN is hereby cancelled and terminated pursuant to Section 69-12-327, MCA, and ARM 38.3.120 for the failure of this carrier to complete required compliance by filing evidence of Tariff with the Montana Public Service Commission. All rights and privileges granted under and by virtue of Final Order No. 6469 and Order on Reconsideration 6469a are hereby cancelled and terminated.

IT IS FURTHER ORDERED that a copy of this Order be sent by certified mail to the above-named carrier. DONE IN OPEN SESSION on the 10th day of April, 2000, at Helena, Montana by a vote of 5 - 0.
