CANCELLATION ORDER

Tomm Furcht dba Classic Airport Sedans, Missoula, Montana, is the owner and operator of Intrastate Certificate of Public Convenience and Necessity PSC No. 9407, issued by the Montana Public Service Commission (Commission), pursuant to Title 69, Chapter 12, Montana Code Annotated (MCA).

WHEREAS, Section 69-12-421, MCA, provides that all motor carriers at the time of issuance of their permits and annually thereafter must pay an annual fee of \$5.00 to the Public Service Commission for every motor vehicle operated by the carriers over or upon the State's Public Highways, except for those vehicles maintained and used by the carrier as standby or emergency equipment.

The Montana Public Service Commission issued an Order to Show Cause, under the provisions of 69-12-402, MCA and Title 69, Chapter 12, ARM, sent by certified mail to the carrier on July 5, 2000, requiring the carrier to show cause within ten (10) days after receipt of the Order why the Public Service Commission should not cancel and terminate Intrastate Certificate PSC No. 9407. The Commission received the return receipt showing acceptance of delivery on July 6, 2000. The carrier has failed to show cause within the time allowed why PSC No. 9407 should not be cancelled.

NOW, THEREFORE, IT IS ORDERED that Intrastate Certificate of Public Convenience and Necessity, PSC No. 9407, owned and operated by Tomm Furcht dba Classic Airport Sedans, Missoula, Montana, is hereby cancelled and terminated pursuant to 69-12-327, MCA and ARM 38.3.120. All rights and privileges granted under and by virtue of Intrastate Certificate PSC No. 9407, are hereby cancelled and terminated.

IT IS FURTHER ORDERED that a copy of this Order be sent by certified mail to the above named carrier.
