CANCELLATION ORDER

Flathead Area Custom Transportation, Inc. dba Kalispell Taxi and Airport Shuttle Service, PO Box 2508, Kalispell, Montana 59901-2508, is the owner and operator of Intrastate Certificate of Public Convenience and Necessity PSC No. 9404, issued by the Montana Public Service Commission (Commission), pursuant to Title 69, Chapter 12, Montana Code Annotated (MCA).

The above described Intrastate Certificate holder requested and received the maximum suspension allowed under §§ 69-12-404(1) and 69-12-404(2), MCA.

The Montana Public Service Commission issued an Order to Show Cause, under the provisions of §69-12-404(2), MCA and Title 69, Chapter 12, ARM, sent by certified mail to the carrier on November 21, 2002, requiring the carrier to show cause within ten (10) days after receipt of the Order why the Public Service Commission should not cancel and terminate Intrastate Certificate PSC No. 9404. The Commission received the return receipt showing acceptance of delivery on December 3, 2002. The carrier has failed to show cause within the time allowed why PSC No. 9404 should not be cancelled.

NOW, THEREFORE, IT IS ORDERED that Intrastate Certificate of Public Convenience and Necessity, PSC No. 9404, owned and operated by Flathead Area Custom Transportation, Inc. dba Kalispell Taxi and Airport Shuttle Service, PO Box 2508, Kalispell, Montana 59901-2508, is hereby cancelled and terminated pursuant to § 69-12-327, MCA and ARM 38.3.120. All rights and privileges granted under and by virtue of Intrastate Certificate PSC No. 9404, are hereby cancelled and terminated.

IT IS FURTHER ORDERED that a copy of this Order be sent by certified mail to the above named carrier.
