CANCELLATION ORDER

Riedelinger Investments, Inc. dba Yellowstone Taxi, West Yellowstone, Montana, is the owner and operator of Intrastate Certificate of Public Convenience and Necessity, PSC No. 9421, issued by the Montana Public Service Commission, pursuant to Title 69, Chapter 12, MCA.

The above-described Intrastate Certificate holder is a regulated motor carrier, who under the provisions of Title 38, Chapter 3, Subchapter 7, ARM is required to file evidence of required insurance coverage. The above-described Intrastate Certificate holder has failed to file such required insurance coverage.

The Montana Public Service Commission issued an Order to Show Cause under the provisions of 69-12-404(2), MCA, sent by certified mail to the official mailing address on file for this motor carrier and it was returned as unclaimed.

NOW THEREFORE IT IS ORDERED that Intrastate Certificate of Public Convenience and Necessity PSC No. 9421, owned and operated by Riedelinger Investments, Inc. dba Yellowstone Taxi, West Yellowstone, Montana is hereby cancelled and terminated pursuant to

Section 69-12-404(2), MCA. All rights and privileges granted under and by virtue of Intrastate Certificate PSC No. 9421, are hereby cancelled and terminated.

IT IS FURTHER ORDERED that a copy of this Order be sent by certified mail to the above-named carrier.
