The Commission, being fully advised in the premises, makes the following findings, conclusions and order:

FINDINGS OF FACT

1. On September 26, 1994, Great Falls Capital Corporation, 104 2nd Street South, Suite 203, Great Falls, MT 59401, filed an application with the Montana Public Service Commission under Title 69, MCA, for a Certificate of Public Convenience and Necessity authorizing transportation of the following:

Class B - Persons and baggage between points and places within a 150 mile radius of Great Falls, Montana.

Limitations: 1) Transportation must originate at facilities located at the Great Falls International Airport. 2) Transportation is limited to taxi's or vehicles with a maximum seating capacity of six individuals including the driver.

2. In accordance with Section 69-23-321, MCA, this matter was noticed to the public October 4, 1994. That notice said in pertinent part:

If no written protests are received by October 24, 1994, a hearing may not be held and a final order may be issued in this Docket. If a protest is received, a hearing will be scheduled. Individual notice of the hearing will be given only to Protestants and Applicant.

The application included affidavits of support.

3. Protests were filed by P.S. Charter Montana, Havre, Montana and Camelot Limousine Company, Missoula, Montana. The protests were later withdrawn

IT IS FURTHER ORDERED that a full, true and correct copy of this order be sent forthwith by first class mail to the applicant and all parties herein.

THE FOREGOING ORDER was adopted by the Department of Public Service Regulation of the State of Montana, Public Service Commission, IN OPEN SESSION at Helena, Montana, this 14th day of November, 1994, by a vote of 5 - 0.
