The Commission, being fully advised in the premises, makes the following findings, conclusions and order:

FINDINGS OF FACT

1. On March 1, 1995, Roland & Lisa Morris dba Mission Valley Medicab, 10207 Wheatland Road, Moiese, Montana 59824 filed an application with the Montana Public Service Commission under Title 69, MCA, to amend PSC No. 9199, Certificate of Public Convenience and Necessity, to authorize transportation of the following:

Class B - Nonemergency medical and psychiatric patients from Granite, Lake, Mineral, Missoula, Ravalli, and Sanders Counties to medical appointments at health care facilities in Flathead, Granite, Lake, Mineral, Missoula, Ravalli, and Sanders and return.

2. In accordance with Section 69-23-321, MCA, this matter was noticed to the public March 7, 1995. That notice said in pertinent part:

If no written protests are received by March 27, 1995, a hearing may not be held and a final order may be issued in this Docket. If a protest is received, a hearing will be scheduled. Individual notice of the hearing will be given only to Protestants and Applicant.

The application included affidavits of support.

3. A protest was filed by Granite County Memorial MAF & Nursing Home, Philipsburg, Montana. On July 5, 1995, the protest was withdrawn.

**CONCLUSIONS OF LAW**

1. The Montana Public Service Commission properly exercises jurisdiction over the parties and subject matter in this proceeding.

2. The Commission afforded all parties interested in this proceeding proper notice and an opportunity to participate.

3. Public Convenience and Necessity require a grant of the authority sought by the Applicant.

**ORDER**

NOW THEREFORE, at a session of the Public Service Commission, Department of Public Service Regulation of the State of Montana, held in its offices at 1701 Prospect Avenue, Helena, Montana, on the 17th day of July, 1995, there being present a quorum of Commissioners, there came regularly before the Commission for final action the matters and things in Docket No. T-95.18.PCN, and the Commission being fully advised in the premises;

IT IS ORDERED by the Commission that the application of Roland & Lisa Morris dba Mission Valley Medicab, 10207 Wheatland Road, Moiese, Montana, Montana, for a Certificate of Public Convenience and Necessity IS GRANTED to the following extent:

**Class B** - Nonemergency medical and psychiatric patients from Granite, Lake, Mineral, Missoula, Ravalli, and Sanders Counties to medical appointments at health care facilities in Flathead, Granite, Lake, Mineral, Missoula, Ravalli, and Sanders and return.

IT IS FURTHER ORDERED that a full, true and correct copy of this order be sent forthwith by first class mail to the applicant and all parties herein.

THE FOREGOING ORDER was adopted by the Department of Public Service Regulation of the State of Montana, Public Service Commission, IN OPEN SESSION at Helena, Montana, this 17th day of July, 1995, by a vote of 5 - 0.
