CANCELLATION ORDER

NOW THEREFORE IT IS ORDERED that Intrastate Certificate of Public Convenience and Necessity PSC No. 9283, owned and operated by Clinton Erickson & Greg Eppe, a partnership dba P.A.C. Services is hereby cancelled and terminated pursuant to Section 69-12-327, MCA, and ARM 38.3.120 for the failure of this carrier to file an annual report and filing fee of \$25.00 before April 1 with the Montana Public Service Commission covering the financial operation of the carrier as relate to the business of transportation by the carrier, Section 69-12-407, MCA, and ARM 38.3.805. All rights and privileges granted under and by virtue of intrastate Certificate PSC No. 9283 are hereby cancelled and terminated.
