CANCELLATION ORDER

Carr-Funke Moving and Storage, Inc., % Bill Carr, General Manager, 5902  
Creek Road, Billings, Montana 59106, the owner and operator of Intrastate  
Certificate of Public Convenience and Necessity, PSC No. 4553, issued by the  
Montana Public Service Commission, pursuant to Title 69, Chapter 12, MCA.

The above-described Intrastate Certificate holder is a regulated motor  
carrier, who under the provisions of 69-12-404(1), MCA applied for and received  
permission to suspend intrastate operations for two consecutive six month  
periods. The above-described Intrastate Certificate holder has failed to  
reactivate the authority as required by 69-12-404(2), MCA.

The Montana Public Service Commission issued an Order to Show Cause under  
the provisions of 69-12-404(2), MCA, sent by certified mail and received by  
carrier on July 9, 1999 requiring the carrier to show cause within ten (10) days  
after receipt of the Order, why the Public Service Commission  
should not cancel and terminate the Intrastate Certificate PSC No. 4553.

NOW THEREFORE IT IS ORDERED that Intrastate Certificate of Public  
Convenience and Necessity PSC No. 4553, owned and operated by Carr-Funke Moving  
and Storage, Inc., Billings, Montana is hereby cancelled and terminated pursuant  
to Section 69-12-404(2), MCA. All rights and privileges granted under and by  
virtue of Intrastate Certificate PSC No. 4553, are hereby cancelled and  
terminated.

IT IS FURTHER ORDERED that a copy of this Order be sent by certified mail  
to the above-named carrier.
