Commissioner Lake moved to APPROVE the Commission Minutes for the week of March 21, 2016. Commissioner Koopman seconded the motion, which passed unanimously.

Commissioner Kavulla moved to GRANT reconsideration, withdrawing the Procedural Order

finding that NorthWestern has declined to address additional issues; DIRECTING staff to issue an order resolving the three issues raised by the MCC in the MCC's favor, as would the stipulation; finding that modeling costs that NorthWestern proposes to recover are not supported by evidence as "electricity supply costs" and that good cause exists to extend MAPA's deadline another 30 days for the issuance of an order. Commissioner Koopman seconded the motion, which passed unanimously.


(64) In the matter of D2013.5.33 and D2014.5.46: NorthWestern Energy's electric tracker.

MAIN MOTION: Commissioner Koopman moved ISSUE and order finding that the replacement power costs caused by the Colstrip outage were imprudently incurred, that because no stipulation resolving the admissibility of certain data requests was received that the Commission will determine their admissibility in the final order, and that good cause exists for the Commission to extend the deadline for an issuance of the order another 30 days. Commissioner Kavulla seconded the motion.




The main motion as amended passed 3 to 2. Commissioners Lake and Bushman dissenting.


There being no further business to come before the Commission the meeting was adjourned.
