 - d. Public commenters will make comments only once near the beginning of the business meeting. Commenters are welcome to remain online to listen to the entire meeting.
 - e. You may also provide written comments as outlined in paragraph (1) under "Public Involvement." These comments are not made publicly available but are provided to the docket work team and Commissioners.
- (6) sign up on the Commission's "Email List" to receive Notices by email for the following categories: Rules, Motor Carrier, Energy West Applications, MCC & PSC Taxes, Montana-Dakota Utilities Applications, NorthWestern Energy Applications, PSC Orders, Telecommunications Applications, PSC Agendas, and PSC Hearings;
