1. Mountain Water Co. D2014.12.99 (Jeremiah)

On May 27, 2015, Mountain Water Company and Western Water Holdings, LLC filed a *Motion for Protective Order* (Motion) to keep confidential certain financial, organizational, and other commercially sensitive information contained in a portion of the Confidential Information Memorandum and Management Presentation that were previously redacted on the basis of discoverability when those documents were initially produced in response to PSC-028(b) and PSC-029(b). Specifically, this Motion concerns information regarding Park Central Basin's and Apple Valley's historical and projected financial performance; information regarding the existing market and growth opportunities for Park Central Basin and Apple Valley; information regarding

Part Central Basin's water sourcing strategy/water rebalancing plan; and details regarding planned capital investment for Apple Valley.

2. Mountain Water Co. D2014.12.99 (Jeremiah)

On May 14, 2015, Mountain Water Company and Western Water Holdings, LLC filed a *Motion for Protective Order* (Motion) in response to the Montana Public Service Commission's Order No. 7392c and a subsequent Order on Reconsideration. This Motion concerns information regarding executive tax loans responsive to Data Request PSC-014.

3. Mountain Water Co. D2014.12.99 (Jeremiah)

On May 15, 2015, Mountain Water Company and Western Water Holdings, LLC filed a *Motion for Protective Order* (Motion) to keep confidential bank account numbers contained in in two documents produced in response to PSC-024. Specifically, this Motion seeks protection for Park Water Company's and Wells Fargo's bank account numbers contained in the Wells Fargo Loan Agreement and Park Water's and CoBANK ACB's bank account numbers in the CoBANK Term Loan Agreement.
