 - c. You will be given an identifier, such as "Commenter 1, 2, etc." This identifier will be how you are recognized to provide public comment during the business meeting.
 - d. Public commenters will make comments only once near the beginning of the business meeting. Commenters are welcome to remain online to listen to the entire meeting.
 - e. You may also provide written comments as outlined in paragraph (1) under "Public Involvement." These comments are not made publicly

available but are provided to the docket work team and Commissioners.

- (6) sign up on the Commission's "Email List" to receive Notices by email for the following categories: Rules, Motor Carrier, Energy West Applications, MCC & PSC Taxes, Montana–Dakota Utilities Applications, NorthWestern Energy Applications, PSC Orders, Telecommunications Applications, PSC Agendas, and PSC Hearings;
